

# TRIUMPH FITNESS SLOSHBALL TOURNAMENT PARTICIPANT WAIVER AND RELEASE OF LIABILITY

In consideration for being allowed to participate in the Triumph Fitness Sloshball Tournament (the "Tournament") and its related events and activities, the undersigned acknowledges and agrees that:

1) The Tournament is an athletic event that involves serious risk of significant personal injury from the activities involved in the Tournament including, but not limited to dehydration, exhaustion, muscle strain, muscle damage, broken bones, stroke, heart attack, paralysis and death.

2) By participating in the Tournament I knowingly and freely assume the risks of participating in the Tournament and assume full responsibility for any and all personal injury and property damage that I cause to me and to others participating in the Tournament. I agree to hold the sponsors of the Tournament including, but not limited to the Tournament organizers, fundraisers, coordinators, officials, sponsors, advertisers, owners and lessors of the premises used to conduct the Tournament, and other participants in the Tournament, free and harmless for any and all personal injury and/or property damage resulting from my participation in the Tournament, to the fullest extent permitted by law.

3) I agree to fully comply with the rules of the Tournament and immediately report to Tournament organizers and officials any offensive behavior by Tournament participants, and/or dangerous conditions that may endanger any of the Tournament participants.

4) I acknowledge that alcoholic beverages will be consumed by the participants of the Tournament and that the consumption of alcohol presents a risk of serious personal injury and property damage to me and others should I fail to act responsibly. Thus, I acknowledge that it is my responsibility to act responsibly while participating in Tournament events, including making safe arrangements for my transportation to and from the Tournament. I agree to hold the sponsors of the Tournament including, but not limited to the organizers, fundraisers, coordinators, officials, sponsors, advertisers, owners and lessors of the premises used to conduct the Tournament and other participants, free and harmless for any and all property damage and/or personal injury to myself and others resulting from my consumption of alcoholic beverages at the Tournament, to the fullest extent permitted by law.

5) I agree that this release shall be binding on and inure for the benefit of my heirs, assigns, and personal representatives.

6) I agree that by signing this Waiver and Release of Liability that I have read and I understand the important legal rights and obligations that I am giving up and assuming by participating in the Tournament. With a full understanding of the risks inherent in the Tournament, the rights I am releasing and the obligations that I am assuming, I freely and voluntarily execute this Waiver and Release of Liability and agree to be bound by its terms.
